4. KEN INESON & CHRISTIAN KNIGHT FROM VILLAGE BUILDING CO. (VBC)

9. GENERAL BUSINESS

- **9.1 Workshop with Mayor & General Manager** Kim Howatson met with the Mayor and General Manager and some of the issues raised were –
- Update of housing data
- Bushfire Management Plan this should be done every 5 years
- Heating of the toddler pool this was done a while ago but unsatisfactorily. (Council made an undertaking to look into it.)
- Edwin Land Parkway extension houses backing onto the ELPe will have road noise minimised by a dirt mound but no improvements made to the fences
- Trail Bikes they now have access to bushland since the ELPe work has commenced. Any trail bike activity should be reported to the Police. The JRA have suggested in the past that Council use the rocks dug from the site to create a barrier to deter bike riders.

ACTION – Kim Howatson to reiterate this fact to the General Manager.

- Traffic on Lanyon & Tompsitt the slip lane seems to be working. The JRA thanked Brian Brown for speaking about this with the Minister for Transport who, in turn, contacted the RTA.
- North Terrace lettering on rock wall QCC will not be replacing the lettering
- Mariners Drive Park \$45,000 was set aside in the Management Plan but JRA have been advised that this money won't necessarily be spent on this project
- Jerrabomberra Community Centre (JCC) and Youth Centre the Council still hope to extend the JCC as there is \$1.2m set aside for community facilities in Jerrabomberra. This is not in line with the JRA's position of having a purpose-built Community Centre. The General Manager stated that an additional community centre isn't financially viable.
- Damage to Alan McGrath Oval QCC were advised of this damage but nothing has been done, as yet. The JRA were assured that they would look into it.
- Pond Fishing Event QCC were keen to see this happen. The JRA need to seek further information/guidance to make it happen.
- **9.2 Draft Integrated Plan submission** The JRA have lodged a submission focussing on footpaths, development of Jerrabomberra parkland and various community priorities not being met in the Integrated Plan.
- **9.3 Edwin Land Parkway extension (ELPe)** this has now started.
- **9.4 Safety and Security** NSW Police are advising residents not to leave valuables in their cars as Break & Steal from cars is still happening. An arrest was made in April and this could contribute to fewer robberies in the area.
- **9.5 NSW Fire Brigade** No recent update, although we have some interested residents ready to form Community Fire Units.

ACTION: Doug Gordon to follow this matter up with NSWFB.

- **9.6 Canberra Airport** Margot Sachse spoke at the Senate Inquiry into the Effectiveness of AirServices Australia's Management of Aircraft Noise and has since submitted a question on notice involving the 'dodgy' Practical Ultimate Capacity ANEF. Kim Howatson also attended this inquiry.
- **9.7 Community Bank** Brian Brown attended a Board Meeting today (June 19) and the prospectus is currently being progressed. All is going well and it is anticipated that the prospectus should be out by late July/early August, 2010. An appropriate site for the bank also needs to be found.
- **9.8 Chronicle Article** It was suggested that one item worth mentioning was the upcoming tour of the Quarry.
- **9.9 Guest Speakers** July speaker will be Peter Hewson from Holcim. We will try and get Mike Kelly to attend our August meeting.
- **9.10 Lanyon Drive** ACTION Kim Howatson to seek an update on proceedings from the contractors.

- **11.3 National Volunteering Week Certificates** Certificates were presented to David Hope, Margot Sachse, Lyn Edwards, Dwayne Keefe and Brian Brown in appreciation for all the work they have done as volunteers in the local community over the years.
- **11.4 School Trivia Night** This is being held in co-operation with Karabar High School due to building work being done at Jerrabomberra Public School. The theme for this night is "Colour Our World" and will be held on September 4, 2010. It was further advised that the school fete would be held on November 20, 2010.
